**Information for the manufacturer / applicant**

*Through the conformity attestation it is possible to attest only the properties of a construction product given in the technical specifications as defined in the Act No. 90/1998 Coll. on Construction Products, as amended. Because the necessity to attest conformity of such properties applies to the all manufacturers and all the products of the same type; it is possible for the benefit of a product's success on the market to have attested by an independent third party also other properties of the product, in particular those by means of which this product differs from competitors' products and that are significant for product selection by the future user.*

*It is advantageous both financially and in terms of time for the applicant to apply for conformity attestation at the same time as applying for certification of further properties of the given product and to obtain a certificate by the Accredited Certification Body P- 016 of TSÚS for the products, or to attest product properties through testing in the Accredited Testing Laboratory of TSÚS.*
